5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon on 21st March 2023**. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM and Date 21st March 2023** at the office of **Mayadevi Rural Municipality, Rupandehi**. Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of specified in above table, which shall be valid for 30 days beyond the validity period of the bid (*i.e. 10th June 2023*)

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
