Bidders, submitting their bid electronically, should deposit the cost of bidding document fee non-Refundable in the Project's Rajaswa (revenue) account as specified below.

5. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon on 15 April 2020**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM and Date 15 April 2020** at the office of **Mayadevi Rural Municipality, Rupandehi**. Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of specified below, which shall be valid for 30 days beyond the validity period of the bid (*i.e. 29 Aug 2020*)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
